JAMTHEWIRE PRIVACY POLICY

Protecting your private information is our priority. This Statement of Privacy applies to www.jamthewire.com (hereafter, The Site) and JamTheWire and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to JamTheWire include www.jamthewire.com and JamTheWire. The JamTheWire website is a broadcaster site. By using the JamTheWire website, you consent to the data practices described in this statement.

Collection of your Personal Information. There are 2 types of users, each with different connections to the Site.

- 1) Audience: We do not collect any personal information about our Audience unless you voluntarily provide it by emailing us. Audience members interested in crowdfunding JamTheWire will enter such information on that site, which is beyond JamTheWire's control and will be subject to their privacy policies.
- 2) Artists. Our artists need to provide certain personal information to us directly when applying to be on the Site. These may include: (a) emailing us and providing links to their Media (b) signing up for special offers from selected third parties (such as crowdfunding sites); (c) sending us an email message; (d) submitting your credit card or other payment information when ordering and purchasing services and potentially products on our Site. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. The only additional personal or non-personal information is that which is provided by you to us.

Sharing Information with Third Parties. JamTheWire does not sell, rent or lease its customer lists to third parties. JamTheWire may share data with trusted partners to send you email or postal mail, provide customer support, help perform statistical analysis, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to JamTheWire, and they are required to maintain the confidentiality of your information.

JamTheWire may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on JamTheWire or the site; (b) protect and defend the rights or property of JamTheWire; and/or (c) act under exigent circumstances to protect the personal safety of users of JamTheWire, or the public.

Automatically Collected Information. No information about your computer hardware and software is automatically or intentionally collected, stored or used by JamTheWire, but may be collected by third parties (such as hosting platforms) that JamTheWire uses. This information can include: your IP address, browser type, domain names, access times and referring website addresses.

Right to Deletion. Subject to certain exceptions set out below, on receipt of a verifiable request from you, we will delete your personal information from our records.
